- Learners Understand and comply with plagiarism guidelines by producing independent and original assignments, acknowledging all sources used, and participating in all mandatory academic integrity training provided.

Plagiarism Detection and Prevention Practices:

- Regularly utilize plagiarism detection tools and software (e.g Turnitin or similar platforms) to scan
 all learner submissions for unoriginal content, ensuring objective and systematic review of written
 work.
- Offer comprehensive pre-submission guidance to learners on referencing methods, paraphrasing skills, and the use of academic sources to prevent unintentional plagiarism.
- Take swift, documented action on all suspected cases of plagiarism, including detailed investigations, transparent communication with learners, and the issuing of outcomes or sanctions as per the policy framework.
